- Complete calendar data from iCal, Microsoft Outlook, Google Calendar, Microsoft Exchange Calendar, or any other calendar application that is installed on any university-owned desktop, laptop, tablet computer, or mobile device and used by Professor Nichol.
- Complete calendar data from iCal, Microsoft Outlook, Google Calendar, Microsoft Exchange Calendar, or any other calendar application linked to [gnichol@email.unc.edu](mailto:gnichol@email.unc.edu). This should include appointments, meeting requests, tasks, notes, reminders, etc.
- Call records for 919-962-5928, a university-based phone line.

FOR ANY UNIVERSITY ISSUED OR PAID FOR MOBILE DEVICE ISSUED TO PROF. NICHOL:

- List of devices issued to Professor Nichols or paid for by the University.
- Call logs from any university-issued mobile device used by Professor Nichols.
- Text message records from any university-issued mobile device used by Professor Nichols.
- Emails to or from any email accounts contained on the device used by Professor Nichols

To expedite the information retrieval process, I request that you send any and all of the information requested above in electronic format to my email address: [francis.deluca@nccivitas.org](mailto:francis.deluca@nccivitas.org).

I ask that you let me know and provide me with an estimate if there will be any costs before you proceed with the request. You may reach me at 919-834-2099.

In the event that my request for access to any of the documentation listed above is denied under state law, I request that I be provided with any and all non-exempt portions of the documentation. I further request that you specify the statutory basis for the denial.

I request that you please acknowledge receipt of this request and I thank you for your cooperation. I do not expect a reply until the beginning of next week as this request is being sent on Friday Afternoon.
